## 2 Course structure of the master's programme

The degree covers a standard period of study of three full-time semesters. The course can be started in the summer and winter semester, with the modules in the summer semester being organized by the HSWT in Weihenstephan and the modules in the winter semester being organized by the BFH-HAFL in Zollikofen.

The third semester is reserved exclusively for the master's thesis and the concluding colloquium.

In addition to the obligatory modules and the required elective module in the first semester, elective modules that are not relevant to passing the degree programme can be taken ("Wahlfächer"). It is also possible to take modules offered as general or subject-specific required elective modules (AWPM/FWPM) as an elective module. This requires an additional consultation with the respective lecturers of the AWPM/FWPM.

## **4 Required elective modules and elective modules (Wahlpflichtmodule und Wahlmodule)**

Each student must successfully complete a required elective module worth 5 EC.

Enrolment in required elective modules and elective modules (Wahlmodule) offered at the HSWT usually takes place in the **first week of the semester**. If a student chooses to study more than one required elective module, the surplus required elective modules are converted into elective modules.

In each module or module component selected, students should obtain a performance record (either within or outside of the examination period). The final marks of the required elective modules will be shown on the certificate. (Elective module marks shown only on written request). For organisational and didactic reasons, the number of participants may be limited (minimum and maximum number of participants). If necessary, participants will be determined using a selection process.

Various factors affect whether all required elective modules and elective modules are taught, including whether there are sufficient students interested.

Upon request to the Examining Committee, a module may be selected from the entire range of modules offered by HSWT and the Bavarian Virtual University (VHB). Bachelor students have priority in the event of bottlenecks in the Bachelor elective offer.

Every student can choose elective modules as they wish. As long as there are places available, all general and subject-specific required elective modules (AWPM or FWPM) of the bachelor's programme in Engineering in Forestry can also be voluntarily taken as elective modules. In addition to registering via MyCampus, consultation with the respective lecturer is necessary. ## **5 Protection of students during pregnancy, after childbirth and while breastfeeding**

On 1 January 2018 the law updating maternity protection rights – and therefore a new Maternity Protection Act – came into force. The Maternity Protection Act now also applies to students. The purpose of the law is to protect the health of the woman and her child in her place of study during pregnancy, after childbirth and while breastfeeding. The law aims to enable students to continue their studies during this period without posing risks to their health or that of their children, and to counteract disadvantages during pregnancy, after childbirth, and during the breastfeeding period.

In the compulsory modules of the Master's degree programme, the participation of students during pregnancy, after childbirth and while breastfeeding is possible without any certain restrictions.
